

Tīyā gújā ánīst'ā (I'm very good).

It's important that we remember how fortunate some of us are and that we can always buy these things. There are people and children who need help and anything counts. And of course, a prayer is always powerful.



**AND WHEREAS** Head Chief & Minor Chiefs of the Tsuut'ina Nation have met in a quorum at a duly convened meeting held on October 17, 2025;

**AND WHEREAS** by motion moved by Minor Chief Kelsey BigPlume and seconded by Minor Chief Steven Crowchild and carried,

**THEREFORE BE IT RESOLVED THAT** Head Chief and Minor Chiefs hereby approve the Tsuut'ina Nation Health and Wellness Policies and Procedures in principle, effective October 17,2025, inclusive of technical edits provided by General Legal.

Further, designate the Health Committee as the delegated authority to oversee and approve subsequent amendments to the Health and Wellness Policy in accordance with the Legislative Procedures Act.

Further, the Health Committee is directed to prioritize the completion of substantive amendments identified during the October 2025 Legislative Assembly and ensure these are completed in November 2025.

   Traditional and alternative healing practices are respected.

#### **Confidentiality and Consent**

- Strict confidentiality for participant/client information, with release only by signed consent or legal requirement.
- Informed consent is required for all services, except in emergencies.

#### **Safety and Emergency Management**

- Monthly safety meetings; emergency procedures for fire, flood, and other crises.
- Emergency numbers are posted throughout facilities; 911 is the primary contact for urgent situations.

#### **Quality Improvement**

- Continuous evaluation and improvement of services through annual reviews, surveys, and performance evaluations.
- Data collection supports outcome monitoring and reporting to funders.

#### **Quality Improvement**

- Employees and volunteers adhere to a strict code of ethics, maintaining professional boundaries and respect.
- Participant and Client Bill of Rights: Ensures dignity, safety, informed consent, and freedom from discrimination.

# Remembrance Day 2025

November 11th, 2025



## LEST WE FORGET

To recognize Remembrance Day and Native American Heritage Month, we want to celebrate and honour all the Tsúūt'ínà Veterans who fought and sacrificed for freedom. Remember each year to wear a poppy, attend a service, or take a moment to remember those who we lost for a better future

A service happened on November 11th, at the Chief Joseph Big Plume Administration Building Veterans Hall, started at 10 AM, to remember the Veterans from Tsúūt'ínà. Sīyísgáàs and lest we forget.

## WE WILL REMEMBER THEM.

### Brief Tsúūt'ínà Military History

**1910** - Land on the Tsúūťínà Nation (Reserve) was used by the Military for the first time, over three days of summer training maneuvers.

**1914** - World War I began. Dr. J.V. Follett replaced L.D. McGill as Indian Agent. Lands were surrendered for grazing leases. A new boarding school was erected.

**1914-1916** - Camp Sarcee was established by the Canadian Military on lands leased from the Tsúūt'ínà Nation First Nation.

**1918** - Spanish flu spread across many tribes, mainly through the distribution of infected army blankets previously used by soldiers. As a result, the population was reduced to just 164.

**1921** - Dr. Thomas Murray arrived to observe the school and was appalled at the conditions. He mandated better food, separated the sick children from the healthy, and started a vaccination

program to rid the Reserve of tuberculosis outbreaks. The Department of Indian Affairs agrees to a 100-year military lease on lands in the northeast corner of the Reserve. The previously unspoilt land was deemed unsuitable for any use other than military training due to the damage caused.

1939 - World War II began. Harold Crowchild & Teddy Manywounds were enlisted overseas; Dolly Runner, Leonard Crane, & Fred Eagletail were in service too.

**1942** - *Private Teddy Manywounds*, *RCSAC*, died of pulmonary tuberculosis on 19/02/1942, in the Canadian General Hospital, Colehill, Warwickshire, U.K. He is buried in grave 36F6 of the Brookwood Military Cemetery, Surrey, UK.

**1945** - War hero *Harold Crowchild* returns from Europe. But, as many enlisted First Nations, he was denied government benefits for his refusal to enfranchise.

Tsúūt'ínà Nation, in partnership with the Alberta Employment First Network, hosted a disability employment workshop at the Grey Eagle Hotel. The day-long event covered a number of topics about navigating disability employment issues.

The Information Session was facilitated by Minor Chief Regina Crowchild, and the day began with breakfast, drummers, an opening prayer by Elder Charlie Crowchild, and opening remarks from Acting Xakiji Andy Onespot Sr.

During the session, financial updates on the BMO Capital Trust and Minor Trust, introduction of the Tsúūťínà Finance team, the 2024 – 2025 Financial Statements, and audit results were given. The Tsúūťínà Legal Department provided an update on the Tsúūťínà Water Claim litigation. These sessions are to ensure community engagement outcomes, financial transparency, and to convey vital information on the Water Claim update. Siyisgaas to everyone who attended.

October 2025


Eagle's Flight is a cauldron celebrating the unifying Special Olympics Canada experience and its inspirational athletes, while paying homage to Indigenous wisdom. Resembling a soaring eagle above a mountain, it symbolizes how love can empower people to achieve inspiring dreams.

The three mountain tiers feature the Games' branding, the eight Special Olympics Canada winter sports, and the seven animals representing each Indigenous grandfather teaching. These form the foundation for living inclusively and respectfully. The bowl holding the Flame of Hope is shaped like an eagle, which symbolizes love, and is the embodiment of dreams taking flight.


Eagle's Flight was designed by TC Energy employees and fabricated in collaboration with Boom Construction and Tsúūt'ínà Nation partners using 85 per cent recycled materials. The cauldron was gifted for use at the Special Olympics Canada Winter Games Calgary 2024, which were held Feb. 27-March 2, 2024.

# CANON AE-1 PROGRAM





Film photography hasn't been as popular as it is right now for decades. For beginners and pros, it's a great way to slow down and really focus on the actual photo part of making pictures. Let's be honest, the photos and vintage cameras just look really good.

However, choosing a camera that's right for you can be incredibly challenging. There are so many to choose from, and they all do different things; it can be incredibly overwhelming for a newcomer to film. I've used a number of different 35mm cameras, and I won't be the first or last to tell you that the Canon AE-1 Program is a fantastic place to start or even stay. I could use this camera system as my primary 35mm option every day and be more than happy with it.

Depending on your age, users will instantly recognize the shutter sound when firing the camera for the first time. The iPhone and iPod touch camera sounds are borrowed from this very model. Sounds and looks aside, the Canon AE-1 Program offers a few settings that are familiar to both phone and digital camera users. Automation, not fully automatic, of course, users will still





have to focus the camera manually. Through a series of options, users can set the camera to "Shutter Priority" or "Program". I won't dive deep into operational specifics there are plenty of guides. Speaking of guides, this specific model blew up among influencers and hobbyists as the premier beginner option. This means there is a ton of new support and content to help steer you along your new film journey.


In addition to being well supported by modern creators, the camera sold millions of units and FD lenses. This means there is something for everyone out there to use the camera as they please.



We are all so proud of their accomplishments; they put Tsúūt'ínà on the map in 2025.


