Due to a delay in the administrative verification of candidate qualifications, the release of the official candidate notice will be **extended by one day**.

As per the governing legislation:

- **Section 95 of the Tsuut'ina Nation Head Chief and Minor Chiefs Electoral Code** states:
"A final candidate list will be posted fifteen (15) calendar days after the nominations meeting."
- **Section 38 of the Tsuut'ina Nation Electoral Code Voting Regulations** further clarifies:
"A final candidate list for the Tsuut'ina Nation Head Chief and Minor Chiefs Election shall be posted fifteen (15) calendar days after the nomination meeting or once all candidate verification documents are received."

Address Change

As per Section 23 of the Tsuut'ina Nation Electoral Code Regulations,
"Eligible electors are responsible for providing the CEO or other residential department with their current address."

To ensure mail-out ballots are sent out in a timely and accurate manner, we ask that all eligible voters confirm or update their current mailing address as soon as possible.
