The Tsuut'ina Citizenship Department has fulfilled the request for the Tsuut'ina Electors to participate in the 2025 Tsuut'ina Nation Citizenship Adult Vote, In accordance with the Tsuut'ina Citizenship Code First Amendment.

Section 6 - Acceptance, Rejection and Appeal

(b) If the Citizenship Evaluation Board by majority accepts the application of a person other than a person mentioned in Section 6(a) hereof, then the Citizenship Evaluation Board shall submit the application to the Tsuut'ina Electors and, so long as at least Fifty (50%) percent of the Electors vote on the application, a person shall be granted Citizenship if the majority of the votes approve the application for Citizenship.
