


RULES AND REGULATIONS



Combative Sports R.CS.1711

Under the guidance of Almighty God, Our Creator, and as a sovereign Nation; We, the peoples of Tsuut'ina Nation, in preservation and continuation of the Tsuut'ina Nation's unique culture, identity, traditions, language and institutions, and with respect to the special relationship to the land and resources, in continued relationship with all First Nations and Canada; Do ordain and establish this law in accordance with our inherent right to governance.

Part 1: Interpretation

1. In these rules and regulations, unless the context otherwise requires:
 - (a) "Amateur" is an athlete who has not:
 - i. competed for a money prize, staked bet, or declared wager in any Regulated Sport;
 - ii. competed with or against a professional in any Regulated Sport; or
 - iii. competed in a Regulated Sport as a means of obtaining a livelihood or for obtaining money.
 - (b) "Commission" means the Tsuut'ina Nation Combative Sports Commission established pursuant to the Law or any other commission as authorized by Chief and Council;
 - (c) "Chief and Council" means the Chief and Council of the Tsuut'ina Nation;
 - (d) "Chief Executive Officer" means the Chief Executive Officer of the Tsuut'ina Nation;
 - (e) "Event" includes any exhibition, card, contest or promotion involving the presentation of the Regulated Sport;
 - (f) "Executive Director" means the Nation employee appointed to the Commission by the Chief Executive Officer pursuant to the Law;
 - (g) "In The Ring Rules" means the rules and regulations referenced in Part 12 that relate to the actual rules and regulations that contestants must abide by once they enter the ring (in the case of boxing, kickboxing, or muay thai) or cage (in the case of mixed martial arts), but do not include administrative rules and regulations;
 - (h) "Law" means the Tsuut'ina Nation Combative Sports Law;
 - (i) "Medical Doctor" means a duly qualified medical doctor that is recognized by the Commission for an Event;
 - (j) "Member" means a person appointed to the Commission pursuant to the Law;
 - (k) "Nation" means the Tsuut'ina Nation;
 - (l) "Permit" means a permit issued to a person pursuant to the Rules;
 - (m) "Permit Application" means an application in the form required by the Commission for the issuance of a permit;
 - (n) "Promoter" means a person who organizes, produces or stages an Event;
 - (o) "Rules" means these rules and regulations;
 - (p) "Recognized Amateur Governing Body" means those organizations listed in Part 16 of the Rules; and

(q) “Regulated Sport” includes any of the following: boxing; wrestling; full contact karate; kickboxing; muay thai; mixed martial arts; and any other sport that holds contests where opponents strike each other with a hand, foot, knee or other part of the body.

Part 2: Permits for Promoters

2. No person shall act as a Promoter at the Nation unless that person has been issued a Permit by the Commission (a "Promoter Permit").
3. An application for a Promoter Permit shall contain the following information:
 - (a) the full name, age and address of the Promoter and the Promoter's sponsor (if any);
 - (b) the full name, age and address of any other individuals that may be working with or for the Promoter;
 - (c) a background police check of the Promoter issued by the Tsuut'ina Nation Police Service;
 - (d) if the Promoter is a corporation, the full name, shareholders, directors and senior officers and evidence of good standing;
 - (e) payment of the fee determined by the Commission; and
 - (f) any other documentation or information that may be reasonably required by the Commission.
4. A Promoter Permit Application shall be in writing in the form prescribed by the Commission.

Part 3: Permits for Events

5. No Promoter shall host, organize, produce, announce, advertise, offer to sell tickets or sell tickets in relation to an Event unless that person has been issued a Permit by the Commission (an "Event Permit").
6. An application for an Event Permit shall contain the following information:
 - (a) the type of Regulated Sport;
 - (b) the time and date of the Event;
 - (c) the location of the Event;
 - (d) the expected number of tickets to be sold for the Event;
 - (e) the expected number of bouts to be held at the Event;
 - (f) proof of a valid Promoter Permit;
 - (g) payment of the fee determined by the Commission; and
 - (h) any other documentation or information that may be reasonably required by the Commission.
7. An Event Permit Application shall be in writing in the form prescribed by the Commission. A non-refundable deposit shall be required by the Commission to hold the date for the Event.
8. An Event Permit Application shall be submitted to the Commission not less than thirty (30) calendar days prior to the date of the Event.
9. The Commission shall not issue an Event Permit for a proposed Event when it has previously issued an Event Permit for an Event that is scheduled to be held within seven (7) calendar days of the proposed Event.
10. Where a Promoter is a corporation, the Commission may require its principals to personally guarantee that the Promoter will comply with any conditions listed on an Event Permit and in these Rules.
11. At the beginning of the Event, and during all promotions for the Event, the Promoter shall announce that the Event has been sanctioned by the Commission.
12. A Promoter shall not include, during an Event, an Amateur contest with a professional contest without the permission of the Commission.
13. If the Amateur contests are regulated by a Recognized Amateur Governing Body then the Amateur portion of the Event must be sanctioned separately by that Recognized Amateur Governing Body and the Amateur portion of the Event shall be conducted under the supervision and according to the rules of that Recognized Amateur Governing Body.
14. Notwithstanding the fact that a portion of an Event may be regulated by a Recognized Amateur Governing Body, the Promoter of the Event shall be responsible to provide the insurance coverage and indemnifications set out in these Rules for the entire Event.

Part 4: Conditions of a Permit to Host an Event

15. In addition to any conditions set out in the Event Permit, Event Permits are issued subject to the following conditions unless specifically waived or modified in writing by the Commission:

- (a) The Promoter shall provide the Commission with a performance bond in an amount determined by the Commission at least twenty-one (21) calendar days prior to the Event;
- (b) The Promoter shall provide the Commission with a certified copy of the insurance policy required pursuant to these Rules at least fourteen (14) calendar days prior to the Event;
- (c) The Promoter shall provide the Commission with a signed "Tsuut'ina Nation Combative Sports Commission Hold Harmless Liability and Personal Injury Waiver" in a form satisfactory to General Counsel for the Nation, at least fourteen (14) calendar days prior to the Event;
- (d) The Promoter shall provide the Commission, at least seven (7) calendar days prior to the Event, a line-up of planned contestants which shall include:
 - i. the full name, address and date of birth of each contestant;
 - ii. the written fight record of each contestant;
 - iii. the status of the contestant (amateur or professional) and the weight requirements of each contestant;
 - iv. the details of any bout where the contestant sustained a knockout or technical knockout; and
 - v. detailed information regarding any title belts to be competed for at the Event;
- (e) The Promoter shall immediately inform the Commission of any changes to the contestant line up due to injury or other circumstance and provide the Commission with the information in this section regarding any replacement contestant;
- (f) The Promoter shall provide to the Commission copies of all contestant contracts and a list of prizes for the Event at least seven (7) calendar days prior to the Event;
- (g) Each contestant shall provide all medical and blood work documentation required by the Commission at the weigh-in of the Event. Unless agreed otherwise, it will be the responsibility of the Promoter to provide adequate translations of medical documentation which may not be in English; and
- (h) Each contestant shall provide the Commission with a signed "Tsuut'ina Nation Combative Sports Commission Release, Waiver of Claim and Assumption of Risk", in a form approved by General Counsel for the Nation, and a signed "Tsuut'ina Nation Combative Sports Commission Contestant Declaration of Health", in a form approved by General Counsel for the Nation, along with any other medical documents or forms required by the Commission at least one (1) calendar day prior to the Event.

16. The Promoter shall provide facilities for pre-fight and post-fight medical checks, satisfactory to the Commission.
17. The Promoter shall conform to all applicable laws (provincial, federal and Nation) and shall comply with any directives or resolutions of the Chief and Council.

Part 5: Duties of the Commission

18. The Commission will check to see if any contestant is currently under suspension from any other commissions through www.fightfax.com or such other accepted data base.
19. The Commission will honor the suspensions initiated from other commissions and will not allow suspended fighters to compete at an Event while suspended.
20. Duties of the Commission shall include:
 - (a) supervising weigh-ins;
 - (b) ensuring that each contestant has acceptable blood work documentation and has signed appropriate waivers;
 - (c) conducting a rules meeting to explain the role of the Commission;
 - (d) supervise taping of hands and handing out of gloves;
 - (e) conducting safety inspection of ring or cage and seating of spectators;
 - (f) ensuring presence of medical personnel; and
 - (g) overseeing medical examinations of injured fighters.
21. Only the referee will be able to stop a contest. However, if a Member is concerned about the fitness of a contestant or whether a contestant is properly matched, he or she may ask the ringside Medical Doctor to examine the contestant.

Part 6: Medical Requirements

22. Notwithstanding that an Event Permit has been issued, no Event may start unless and until all medical requirements have been satisfied.
23. All contestants must provide the Commission with up-to-date blood work, which must be signed and dated no longer than two (2) months prior to the Event, or such shorter or longer period as the Commission may deem appropriate. All contestants must provide the Commission with blood work documentation showing negative results for surface antigen, negative results for Hepatitis B and C, and negative results for HIV.
24. Female contestants must also provide the Commission with the results of a pregnancy test which is dated no longer than seven (7) calendar days prior to the Event or provide a home pregnancy test at the weigh-in at their own expense.
25. The Promoter shall provide the results of an electrocardiogram and physical examination for each contestant at the weigh-in of the Event. If a contestant has been knocked-out within the last twelve (12) months, an MRI or CAT scan may be required by the Medical Doctor prior to the Event.
26. The Commission may direct that a contestant appear before a Medical Doctor for an examination to determine whether the contestant is fit to participate in a contest. If, in the opinion of the Medical Doctor, the contestant is not fit to participate, the contestant shall not be permitted to participate in that contest.
27. The Promoter shall ensure that the Event does not include a contestant who is unfit, whether physically, mentally or otherwise. A "Contestant Declaration of Health" will be required to be provided to the Commission prior to the weigh-in.
28. The Commission may appoint one or more Medical Doctors as its ringside Medical Doctor(s) in addition to reasonable medical assistants as required, who shall attend throughout the duration of the Event.
29. The Commission, will, if possible, secure the Medical Doctors for the Promoter, but the ultimate responsibility remains with the Promoter. Medical Doctors, medical assistants all medical expenses shall be the responsibility of the Promoter.
30. The Medical Doctor may, before any Event, inspect all First Aid kits and medical facilities intended to be used at the Event.
31. The Medical Doctor may stop any contest at any time to examine a contestant, or stop any contest at their discretion.

Part 7: Insurance Requirements

32. A policy of liability insurance shall be valid and held in connection with every Event and an Event shall not be held until the Promoter furnishes a Certificate of Insurance satisfactory to the Commission at least fourteen (14) days prior to the Event.
33. Liability insurance must be issued by an insurance company registered and licensed to do business in the Province of Alberta, Canada.
34. Liability insurance must be in the amount directed by the Commission, but not less than Two Million Dollars (\$2,000,000.00), to cover public liability for all personal injury and property damage which may occur by reason of the operation of the Event, with a deductible not exceeding Two Thousand Five Hundred Dollars (\$2,500.00).
35. The insurance shall be endorsed to add the Nation as an **additional named insured**, with 30 days written notice to be given to the Nation prior to cancellation of, or material change to the policy.
36. The insurance is to include the following cross liability clause: "this policy, subject to the limits of liability stated herein, shall apply to each Insured in the same manner and to the same extent as if a separate policy has been issued to each, Any act or omission on the part of one or another of the Insured under this policy shall not prejudice the rights or interests of any other Insured."
37. The insurance is to also include endorsements of:
 - (a) Blanket contractual
 - (b) Cross liability
 - (c) Non-owned automobile
 - (d) All Risk Tenant's Legal Liability Coverage in the amount of not less than Two Million Dollars (\$2,000,000.00), or as directed by the Commission, with a deductible not exceeding Two Thousand Five Hundred Dollars (\$2,500.00).

Part 8: Fighter Permits

38. No person shall participate in a Regulated Sport as a contestant at the Nation unless that person has been issued a Permit by the Commission in accordance with these Rules (a "Contestant Permit").
39. An application for a Contestant Permit shall contain the following information:
 - (a) the full name, age and address of the contestant;
 - (b) a history of the contestant's ring experience;
 - (c) payment of the fee determined by the Commission; and
 - (d) any other documentation or information that may be reasonably required by the Commission.
40. A Permit Application shall be in writing in the form prescribed by the Commission.

Part 9: Fighter Suspension

41. The Commission, in consultation with the attending Medical Doctor at the Event, shall impose the following minimum suspensions:
 - (a) Mandatory twelve (12) calendar day rest period suspension upon completing a contest;
 - (b) Mandatory thirty (30) days suspension for fight stoppages due to cuts or repeated blows to the head; and
 - (c) Indefinite period of suspension due to specific medical concerns as identified by the Medical Doctor. The indefinite period of suspension to continue until medical information specifically requested by the Medical Doctor has been received, reviewed and approved.
42. Participation in any Regulated Sport during a suspension period will result in a further suspension being instituted against a competitor.
43. The Commission will submit all suspensions to www.fightfax.com or to such other accepted data base.
44. The Commission will advise a competitor, in writing, of any suspension prior to the competitor leaving the venue after an Event.

Part 10: Discipline

45. Every person involved in a contest shall conduct themselves in a fair, honest, ethical, and sportsmanlike manner in relation to the Regulated Sport.
46. Promoters, managers and competitors in the Regulated Sport shall satisfy their contractual obligations arising from fight contracts, management contracts, and other contracts pertaining to the Regulated Sport, and the Commission may deem a breach of such a contract to be a breach of these Rules.
47. If the Commission determines that a Promoter, manager or competitor has breached a fight contract, management contract, or other contract pertaining to the Regulated Sport, or has breached these Rules, or has acted in a manner that could bring the Regulated Sport into disrepute, or has otherwise failed to properly conduct himself or herself in relation to the Regulated Sport, the Commission may suspend the person and/or terminate his or her Permit.
48. Any contestant who knowingly participates in a contest with a contestant who has been suspended by the Commission, or who knowingly participates in a contest promoted by a Promoter who has been suspended by the Commission, may be suspended by the Commission.
49. The Chair of the Commission may suspend the participation privileges of a person against whom allegations have been made pending a review by the Commission of those allegations.
50. Any decision of the Commission is final and binding.

Part 11: Weigh in Procedures for the Regulated Sport

51. The scale shall be provided by the Commission. The scale and venue used for the weigh-ins shall be available to the participants at least one (1) hour prior to the scheduled weigh-in. The Commission shall supervise the weighing-in of all competitors, and shall be open to the public.
52. A competitor who fails to make the weight agreed upon in that competitor's bout agreement forfeits twenty (20%) percent of his or her purse, unless the weight difference is one (1) pound or less. The amount forfeited shall be given to that competitor's opponent.
53. Unless otherwise approved by the Commission, the rules meeting will occur at the same time and location as the weigh-ins.

Part 12: In the Ring Rules

54. A Promoter shall ensure that the In The Ring Rules and scoring and judging rules for an Event, as set out in this Section, are adhered to at all times during an Event.
55. All Events shall be conducted in accordance with the rules and regulations set out in Part 13 of these Rules.
56. Where there is a conflict between the In The Ring Rules and a provision of these Rules, these Rules shall prevail.
57. All Regulated Sport bouts shall be governed by the In The Ring Rules, scoring and judging rules set out below:
 - (a) for professional boxing bouts the rules of the Nevada State Athletic Commission shall be used;
 - (b) all combative sports Events involving Muay Thai shall be conducted in accordance with the rules and regulations set by the World Muay Thai Council, as amended from time to time;
 - (c) all combative sports Events involving Kickboxing shall be conducted in accordance with the rules and regulations set by the World Kickboxing Association, as amended from time to time;
 - (d) all combative sports Events involving Mixed Martial Arts shall be conducted in accordance with the Unified Mixed Martial Arts Rules and regulations set by the Nevada State Athletic Commission, as amended from time to time.
58. In addition to the In The Ring Rules set out for Mixed Martial Arts above, the following tactics shall be considered fouls for Amateur Mixed Martial Arts contests:
 - (a) Butting with the head
 - (b) Eye gouging of any kind
 - (c) Biting
 - (d) Hair pulling
 - (e) Fish Hooking
 - (f) Groin attacks of any kind
 - (g) Putting a finger into any orifice, cut or laceration of an opponent
 - (h) Small joint manipulation
 - (i) Striking to the spine or to back of the head
 - (j) Throat strikes of any kind, including grabbing of the trachea
 - (k) Clawing, pinching or twisting of the flesh
 - (l) Grabbing the clavicle

- (m) Kicking the head of a grounded opponent
- (n) Stomping a grounded opponent
- (o) Spiking an opponent to the canvas on his head or neck
- (p) Holding the shorts or gloves of an opponent
- (q) Spitting at an opponent
- (r) Engaging in an unsportsmanlike conduct that causes injury to an opponent
- (s) Throwing an opponent out of the ring or over the cage fence
- (t) Holding the fence or ropes
- (u) Using abusive language
- (v) Attacking an opponent after the bell has sounded to end the round
- (w) Attacking an opponent on or during the break
- (x) Attacking an opponent who is under the care of the referee
- (y) Flagrantly disregarding the instructions of the referee
- (z) Interference by the corner men
- (aa) Attacking the opponent with elbow or knee strikes to the head, standing or on the ground
- (bb) Timidity, including without limitation, avoiding contact with an opponent, intentionally or consistently dropping the mouthpiece or faking an injury
- (cc) Knee strikes to the head of a grounded opponent
- (dd) 90 degree spiking elbows.

59. The tactics considered fouls for Amateur Mixed Martial Arts contests are also considered fouls for professional Mixed Martial Arts contests with the exception of 58(aa).

60. Professional contestants are allowed elbow and standing knee strikes to the head of a standing opponent as well as elbow strikes to the head of an opponent on the ground.

61. Where there is a dispute regarding which rules provided for in this Section shall apply to a combative sports Event, the applicability of a rule shall be determined by the Commission and the decision of the Commission shall be final and binding.

Part 13: Event Rules

62. A maximum of eighteen (18) bouts per Event are permitted, and must be completed by 2:00 am, unless special permission has been obtained from the Commission.
63. A Promoter shall at all times maintain good order in and about the premises used for an Event, and shall maintain a sufficient staff of properly identified and trained personnel for that purpose.
64. A Promoter shall take all reasonable measures to provide for safety, security and medical emergencies, and notwithstanding that an Event Permit has been issued, the Commission may refuse to allow an Event to proceed if it appears to the Commission that the Promoter has failed to take reasonable measures.
65. A Promoter shall ensure that all Members have free access to the Event and have access at the Event to ensure that reasonable measures have been taken to provide for safety, security and medical emergencies.
66. A Promoter shall provide trained identifiable security staff and arrange for uniformed members of the Tsuut'ina Nation Police Service to be in attendance at an Event. Prior to the Event, a Promotor shall provide the Commission with details about the security measures to be taken.
67. Without limiting, a Promoter shall ensure that all competitors have safe access to and from the ring or cage. All seating immediately adjacent to the ring or cage where a contest takes place shall be barricaded to separate the contestants, officials, and Members and this area shall be under the control of the Commission.
68. A Promoter shall ensure the presence, at all times during the course of an Event, trained medical staff and shall provide unobstructed access at the Event for the medical staff. All costs associated with the foregoing shall be at the sole expense of the Promoter.
69. A Promoter shall provide facilities at the Event for pre-fight and post-fight medical checks as may be specified or required by the Commission. All costs associated with the foregoing shall be at the sole expense of the Promoter.
70. Each contestant will be allowed a maximum of three (3) corner men to accompany him or her to ring side and to coach the contestant during the fight, except for a title fight in which each contestant will be allowed a maximum of four (4) corner men. The contestant will designate which individual will attend the contestant in the ring between rounds.
71. Only three (3) persons per contestant are allowed access to the dressing rooms of the contestants, other than Commission Members and appointed inspectors and officials, except for a title fight in which each contestant will be allowed a maximum of four (4) persons.
72. Unless the Commission agrees otherwise, the Promoter shall supply and ensure all corner men and seconds, and referees wear medical gloves while working a bout.
73. The Promoter shall ensure that opponents wear different colour gloves and/or different colour shorts and/or different colour tape is on the gloves.

74. The Promoter shall supply all gloves of adequate size as approved by the rules of the bout as well as gauze and tape. A fighter may use his or her own guaze and tape.
75. The Commission may require random drug testing. A test can be requested from a fighter at any time before or after a bout.
76. If a fighter tests positive for any substance banned by the rules of that fighter's sport, the fighter will be suspended from competing in any Commission-sanctioned Event, for a period to be determined at the discretion of the Commission.
77. If a fighter fails to give a sample on request, the fighter will automatically be suspended for a period to be determined at the discretion of the Commission.
78. Regulated Sport Events held at the Tsuut'ina Nation cannot be televised or broadcasted without the consent of the Commission.
79. The appointment of all officials taking part in an Event shall be subject to the approval of the Commission.

Part 14: Facilities and Equipment

80. A Promoter shall provide a ring, cage and dressing room facilities satisfactory to the Commission. A Promoter shall provide an adequate supply of unopened bottled water for all contestants, officials, and Members.
81. A Promoter shall provide all necessary non-personal equipment (subject to approval by the Commission) for use by contestants and seconds. This necessary non-personal equipment shall include corner posts and water buckets.
82. A Promoter shall also provide the padded protection equipment to be worn on the hands of each contestant to ensure that matched contestants wear equipment of the same quality and size.
83. The Commission shall provide a bell or gong, positioned at ringside no higher than the floor level of the ring. The bell or gong must carry a clear tone so that the contestant may easily hear its sound.
84. Contestants shall provide all necessary personal equipment for use by themselves and their seconds in all Commission-sanctioned bouts.
85. All contestants must wear a Commission-approved individually fitted mouthpiece.

Part 15: Officials

86. Only officials approved by the Commission will be allowed to work as officials for Events held at the Nation.
87. The Commission will maintain a current list of all trained and approved officials. This list will be made available to Promoters upon request.
88. The Commission shall arrange for officials for the Event from the approved list. Included in the fee to be paid by the Promoter will be the fees to be paid to the officials.
89. Each official working an Event at the Nation must complete and sign a "Hold Harmless Liability and Personal Injury Waiver", in a form approved by General Counsel for the Nation.
90. Each bout shall be conducted by one referee, three judges, the Medical Doctor, a timekeeper, a scorekeeper, an announcer, a Commission representative and any other official that may be named by the Commission. The Commission shall determine the qualifications standards for all officials.
91. Referee
 - (a) The referee shall be charged with the general supervision of the bout. He or she enforces the rules, promotes safety of the contestants, and ensures fair play.
 - (b) Before starting a contest, the referee shall ascertain from each contestant the name of his or her chief second and shall hold the named chief second responsible for the conduct of the assistant seconds during the progress of the contest.
92. Medical Doctor and Paramedics
 - (a) The Medical Doctor shall sit at the immediate ringside of all bouts. No bout shall be allowed to proceed unless the Medical Doctor is in his or her seat. The Medical Doctor shall not leave until after the decision in the final bout. He or she shall be prepared to assist if any serious emergency arises and shall render temporary or emergency treatments for cuts and minor injuries sustained by the contestants.
 - (b) No manager or chief second shall attempt to render aid to a contestant during the course of a round before the Medical Doctor has had an opportunity to examine the contestant who may have been injured. Time out shall be called for such examinations.
 - (c) No Event shall take place, Amateur and/or professional, without at least one paramedic with Advanced Life Support training and equipment present at ringside for each bout.

Part 16: Amateur Governing Bodies Recognizing by the Commission

93. All Promoters, contestants, referees, timekeepers, judges and other officials authorized by a Recognized Amateur Governing Body to participate in, promote, or hold an Amateur Event supervised by that governing body are deemed to have received the permission of the Commission to do so.
94. Events entirely sanctioned and supervised by a Recognized Amateur Governing Body shall be entirely governed by the rules and regulations set by that Recognized Amateur Governing Body.
95. For the purposes of these Rules the following associations shall be considered a Recognized Amateur Governing Body:
 - (a) Alberta Amateur Boxing Association
 - (b) Boxing Alberta
 - (c) Canadian Muay Thai Council Amateur (Alberta)
 - (d) World Kickboxing Association
 - (e) International Federation of Muay Thai Amateur
 - (f) Canadian Amateur Wrestling Association
 - (g) Alberta Amateur Mixed Martial Arts Association

Part 17: Fees and Charges Schedule

96. Permit Fees:

- (a) The Commission shall, from time to time, set fees to be paid for an Event Permit, which may be a percentage of gate receipts or a flat rate, and shall include an annual Promoter Fee.

97. Other Commission Fees:

- (a) The Commission shall, from time to time, set other fees including non-refundable deposits to hold Event dates, performance bonds and broadcasting fees.

98. When the Commission determines that it requires the expertise of an external consultant to assist the Commission in the regulating of an Event all of the consultation fees shall be payable by the Promoter.

99. Unless otherwise specified, all fees and charges payable pursuant to these Rules shall be paid by certified cheque or money order made payable to "the Tsuut'ina Combative Sports Commission" or to such other commission that has supervised the Event at the conclusion of the Event.

100. Promoters shall pay to the Commission, seven (7) calendar days before an Event is televised or broadcast, the broadcasting fee, as determined by the Commission.

101. The Fees and Charges Schedule may be changed by the Commission.







